Right to Work Update:

With new Bridge Agreements being negotiated at Fort McCoy, we are among the first in the State to deal with the changes required by Wisconsin Right to Work, brought to us courtesy of our esteemed Governor.

A Bridge Agreement is a contract in the Service Contract arena negotiated when a Company or Contractor that is party to a Collective Bargaining agreement changes, which includes our SCA agreements at Fort McCoy and Camp Douglas. When this happens, it constitutes a change that requires inclusion of the modifications dictated by the new RTW law. Many hours of work were required to ascertain the correct language and procedures necessary. This is not a surprise given that decades of Labor Law were overturned by a simplistic piece of legislation rammed through our legislature in a matter of days, but I digress. The outcome of this work was contract language that captures the law's requirements while affording us as much protection as allowed, with most of those protections and guidelines established under Federal Law which the State's Legislation cannot supersede.

I have also been working with our work site committees as to the law's effect. I believe I have covered this with all of our committee boards but all stewards should note and understand the following, which captures our interpretation of the law's consequences and intent:

Memorandums, Addendums, and Letters of Understanding

A Memorandum, Addendum, or Letter of Understanding that <u>creates or allows a</u> situation or condition that does not exist under current contract language may

constitute a modification that requires implementation of the strictures of the Wisconsin RTW law.

A Memorandum, Addendum, or Letter of Understanding that <u>defines a situation or condition that is allowed</u> under current contract language should not require inclusion of the RTW requirements.

I am fully aware that this issue as defined may cause some hardship for our members as I have already participated in lively discussions along those lines. That being said it is important to remember that we did not draft nor participate in the drafting of this law; it was written by monied outside interests whose only goal was to have it become law regardless of the implications. It is imperative to remember that in interpretation, we have no choice but to always error on the side of caution. Our employers may question our interpretation of the law's requirements; I choose to believe that those questions are well meaning. However the bottom line is that misinterpretation causes hardship only for our Union...only for us. We have everything to lose and nothing to gain by a mistake...we will not make that mistake.

When working with our employers keep this in mind. NOTHING can be drafted or signed without the approval of the District if there is any question as to the impact on our current Collective Bargaining Agreements.

Worker Memorial Day

On April 28th, we paused to remember workers who have died while on the job, died from work related injury or illness, or those who lost their lives to workplace violence. As they have for many years, the Western WI AFL-CIO planned the ceremony at Green Island Park in La Crosse, to honor those who have made the ultimate sacrifice.

Speakers at the event included La Crosse Mayor Tim Kabat, John Medinger speaking on behalf of Senator Tammy Baldwin, and State Representatives Steve Doyle and Jill Billings. A proclamation commemorating the day was read by La Crosse 12th District Councilman Francis Formanek. As DBR of District Lodge 66, I was again able to participate in our long standing tradition of reading the poem written for this year's ceremony by retiree Mike Baird from Local Lodge 21, Trane Company.
